object of the declaration: KOPOBOX floor boxes are designed for installation in concrete and double floors. The box is designed for the installation of electrical devices. KOPOBOX boxes are installed in fireproof walls or floors nonflammable. Minimum and maximum temperatures during installation are from -5 ° C to + 60 ° C. The boxes are delivered with screws. The degree of protection box is IP 30. Considering IP, the box is not suitable to be moistened with the floor cleaning machines. KOPOBOX meets the glow-wire test at 850 ° C according to EN 60670-1. The needle burner test was conducted in accordance with ČSN EN 60695-11-5 with satisfactory result.
